Rules of Play for 50/50 Electronic Raffle:

1. The lottery will take place monthly online from November 1st, 2020 to October 31st, 2020.

The series of draws are as follows:

1. Draw #1 November 1 – November 30, 2020
(November 1, 2020 at 9:00am – November 29 at 9:00pm, with the draw and winner announcement taking place on November 30th at 11am)
2. Draw #2 December 1 – December 31, 2020
(December 1, 2020 at 9:00am – December 30 at 9:00pm, with the draw and winner announcement taking place on December 31st at 11am)
3. Draw #3 January 1 – January 29, 2021
(January 1, 2021 at 9:00am – January 28 at 9:00pm, with the draw and winner announcement taking place on January 29th at 11am)
4. Draw #4 February 1 – February 26, 2021
(February 1, 2021 at 9:00am – February 25 at 9:00pm, with the draw and winner announcement taking place on February 26th at 11am)
5. Draw #5 March 1 – March 31, 2021
(March 1, 2021 at 9:00am – March 30 at 9:00pm, with the draw and winner announcement taking place on March 31st at 11am)
6. Draw #6 April 1 – April 30, 2021
(April 1, 2021 at 9:00am – April 29 at 9:00pm, with the draw and winner announcement taking place on April 30th at 11am)
7. Draw #7 May 1 – May 31, 2021
(May 1, 2021 at 9:00am – May 30 at 9:00pm, with the draw and winner announcement taking place on May 31st at 11am)
8. Draw #8 June 1 – June 30, 2021
(June 1, 2021 at 9:00am – June 29 at 9:00pm, with the draw and winner announcement taking place on June 30th at 11am)
9. Draw #9 July 1 – July 30, 2021
(July 1, 2021 at 9:00am – July 29 at 9:00pm, with the draw and winner announcement taking place on July 30th at 11am)
10. Draw #10 August 1 – August 31, 2021

(August 1, 2021 at 9:00am – August 30 at 9:00pm, with the draw and winner announcement taking place on August 31st at 11am)

11. Draw #11 September 1 – September 30, 2021
(September 1, 2021 at 9:00am – September 29 at 9:00pm, with the draw and winner announcement taking place on September 30th at 11am)
 12. Draw #12 October 1 – October 29, 2021
(October 1, 2021 at 9:00am – October 28 at 9:00pm, with the draw and winner announcement taking place on October 29th at 11am)
2. All tickets will only be sold to people who are 18 years of age or older.
 3. Must be in the province of Ontario at the time of purchase.
 4. Tickets are 3 for \$5, 10 for \$10 or 60 for \$20
 5. Tickets will be available online at riverside5050.ca or in office at 110 Victoria Ave, Fort Frances ON, P9A 2B7.
 6. Tickets will be sold using electronic raffle system supplied by Ascend Fundraising Solutions.
 7. After buying tickets online, patrons will receive a confirmation e-mailed to them with their 50/50 registered numbers from a Random Selection System. After buying tickets in person, patrons will receive physical tickets with 50/50 registered numbers from a Random Selection System printed using a handheld device provided by Ascend. No specific numbers can be given as numbers are generated randomly.
 8. The winning ticket number will be selected by a Random Number Generation (RNG) system from all raffle numbers sold for the draw.
 9. The amount of the 50/50 will be displayed at riverside5050.ca.
 10. Each monthly draw will have a guaranteed prize of \$500.
 11. The winning number will be announced on www.riversidefoundation.ca, on the Riverside Foundation for Health Care Facebook page, and through a media release sent to Fort Frances Times and B93 Radio. If information about the winner is collected at time of sale, the winner will be contacted directly.
 12. The winner may claim their prize by contacting Riverside Foundation for Health Care at: (807) 274-4803, or by email at: allison.cox@rhcf.on.ca. The ticket may then be brought to 110 Victoria Ave, Fort Frances, ON at an agreed upon time for ticket verification. The winner will then be paid by cheque for the amount posted at the event for which they bought their ticket. Winners must have the original winning ticket and no copies. **All payments will be made by cheque.**
 13. The winning ticket holder has **6 months** in which to claim their prize from the date of the draw their ticket was purchase for.
 14. The winner must provide his/her name, address, and phone number with picture identification for our report sheet.

15. Once the certified winner is verified, and provides identification with photo ID, they will be given a cheque in the amount of the declared prize which is, at minimum, 50% of the total sales for that draw. If the winner cannot provide photo ID, then the winning proceeds will be held until such identification can be provided.

16. In the event that no winner comes forward, the winning stub will be kept in a safety deposit box and held for 6 months. After that time period has elapsed the prize will be donated to a charity other than Riverside Foundation for Health Care with the approval of the Alcohol and Gaming Commission of Ontario (AGCO).

17. The following individuals are not eligible to participate in the 50/50 draws:
Any paid employees of Riverside Foundation for Health Care and any volunteers that sit on the Riverside Foundation for Health Care Board of Directors or Special Events Committee.
